RFUANZ STANDARD TERMS FOR EMERGENCY LIAISON CHANNEL

1.0 The Agreement

- 1.1 The terms below apply to the provision of mobile radio communications to you by RFUANZ, except to the extent where they have been modified in writing.
- 1.2 RFUANZ may vary this Agreement from time to time by notice in writing to you and any such amendment shall be binding upon receipt by you or any later date stated in the notice.

2.0 The Service

- 2.1 RFUANZ will permit access to simplex channel MSNX47, 158.64375MHz for the purpose of liaison with other parties during an emergency situation.
- 2.2 The licence held by RFUANZ provides for only analogue operation complying with a 12.5KHz channel spacing specification.
- 2.3 CTCSS tone A6 (123.0Hz) is required on this channel.
- 2.4 Only equipment complying with the relevant MBIE specification or it's equivalent are permitted on this channel.
- 2.5 RFUANZ cannot guarantee effective operation on this channel at any particular time or location.
- 2.6 The channel is available for use anywhere within New Zealand.
- 2.7 The channel is not to be used for day to day operations.
- 2.8 The channel must only be fitted to radios covered by an existing repeater or simplex radio licence.

3.0 Radio Frequencies

- 3.1 In accordance with Clause 13 (2) of the Radio Communications Regulations 2001, you agree to comply with all terms, conditions and restrictions that apply to the RFUANZ licence as though you were the licensee.
- 3.2 RFUANZ is the exclusive licensee of the simplex channel and reserves the right to change the conditions of the licence at any time (but will use reasonable efforts to avoid making any changes)
- 3.3 RFUANZ reserves the right to authorise any other party to access the channel without reference to existing users.

4.0 Abuse of Service

- 4.1 You may not use or permit anyone else to use the channel for any unlawful purpose or in a manner which interferes with the provision of access to other parties.
- 4.2 RFUANZ may, by notice in writing, withdraw approval to use the channel if it reasonably believes you have breached clause 4.1.

5.0 Entire Agreement

5.1 This Agreement comprises the entire agreement between us in relation to access to the channel.
